Area of Study 2: Presenting Argument

On completion of this unit the student should be able to construct a sustained and reasoned point of view on an issue currently debated in the media.

Task:

You must write and present a 4 - 5 minute (600 - 800) word **persuasive speech** on a selected issue recently debated in the Australian media. You will also complete a written **statement of intention** (200 - 300 words). You will deliver your speech to your English class, and times will be allocated at random.

- 1. Choose one of the issues from the list below, or negotiate one with your teacher.
- 2. Under the VCAA rules, your teacher is required to cite the following material <u>prior</u> to your speech in order to make sure your work is your own:
 - a. A bibliography and outline of your issue.
 - b. A plan of your speech.
 - c. A complete draft of your speech.
- 3. You may prepare cue cards or an annotated script to use during your speech. If so, these will be submitted to your teacher after your presentation.
- 4. You must rehearse your speech.
- 5. **Note**: no students can receive assistance from their teacher after Friday of Week 8 (17 June 2019).
